#### **HIGHLIGHTS**

# **Being part of the Bellarine**

The BHA has been a strong supporter and leader in the establishment of the Combined Bellarine Community Associations. This group has really strengthened in 2017/2018, starting with a series of election forums leading up to the CoGG council elections. We meet bi-monthly or as required and have developed a trust and capacity to share information and collaborate on matters of mutual interest. Members include representatives from community associations from Portarlington, Indented Head, St Leonards, Ocean Grove, Breamlea, Drysdale, Clifton Springs and Point Lonsdale. Judith Brooks and I have been the representatives from the BHA; we will encourage others to attend this year.

## The return of an elected Council

We welcomed the return of elected Councillors in November, and in particular our three Bellarine Ward Councillors Stephanie Asher, Jim Mason & Trent Sullivan. This is a hard gig, and not only have they had to work out priorities for the Bellarine, they have had to deal with all the other CoGG issues. There is little doubt that The City of Greater Geelong is a big complicated beast. Is it too big? Should coastal towns like Barwon Heads be part of it?

Our Councillors have always been available and willing to talk; can they deliver what we want – I don't know.

## Ozone Rd Jetty & Water Quality in the Barwon River

The City of Greater Geelong installed a new stormwater discharge outfall at the Ozone Rd Jetty. We expressed our concerns about the scale of the project, the inappropriate location of a major stormwater drain into the Estuary, and the implications of the construction activities. During the process we became a pseudo project manager and were more involved than we should have been. The design of the drain failed to properly take into account the changing sand levels and difficult construction conditions. So amended plans were required and the outfall is not fully submerged. In March we sought an undertaking from CoGG that they:

- Remove the sand build-up on the road at the intersections of Ozone Rd & Flinders Pde.
- Liaise with Barwon Coast to investigate vegetation acceptable / required to provide additional stabilization to the sand embankment next to the Eastern side of the road.
- Remove rock from the surface of the beach
- Review again when these works are done

The beach is still covered in sharp chards of construction blue metal and larger rocks from below the ground in the tidal zone, it is significantly degraded and in an unacceptable condition. This material should have been collected and removed from the site rather than be spread over the beach. We continue to press CoGG and Barwon Coast for substantial improvement.

This was not a good project for Barwon Heads, and highlighted a weakness at CoGG and its capacity to plan such complicated projects.

However – we met some good people. The BHA with significant input from our Committee members John Nolan, a qualified engineer and Judith Brooks have overseen the establishment of the Barwon Estuary Public Health Water Quality Monitoring Project, with stakeholder's meetings held with agencies late last year.

Our goal is to have an ongoing and integrated water quality-monitoring program of the Barwon River, its estuary and local beaches established with ready community access to the monitoring data and reporting of expected future conditions. The monitoring would focus on public heath indicators for recreational uses. We have recently been informed that there is \$15,000 funding from DWELP for a project to be overseen by the Corangamite Catchment Authority.

Our local member Lisa Neville is the Minister for Water; she has been kept well-informed and provided support and encouragement.

### **PLANNING**

Planning has continued to be a major challenge for Barwon Heads residents and the BHA. This will be an ongoing challenge without proper protections and recognition of the frailty of our location. Where are the best practice guidelines for coastal development? Where is innovation recognised and encouraged? Why aren't the community valued and listened to as the major stakeholders, rather than the bureaucrats fixated with ensuring low cost housing and development anywhere.

This has been a challenging and disappointing year. Our members face significant challenges to the peace, quiet and privacy that they have come to expect as residents of

the Village of Barwon Heads. Single lots of land are being subdivided and single story houses replaced by bland 2/3 story structures. The failure to protect vegetation and provide adequate parking continue to grow as significant issues. We have been putting in objections to applications that set poor precedents and threaten the coastal village amenity.

#### **Barwon Heads Structure Plan 2017 - C375**

This has been a major project for the BHA and the community. Council wrote to all households inviting comment on amendment C375, it failed to do this when the residential growth zone was applied to most of Barwon Heads. The proposed plan was advertised in February and we responded with 2 submissions one planning based and the other traffic based.

We supported the recommendation to retain the town boundaries and to protect Warrenbeen Court.

We argued for further changes including:

- removal of the IHDA on the bases that Barwon Heads does not have an "activity centre", is not a commercial mixed use or former industrial area and is not accessed by trains/buses to a central hub.
- Heights of 11m are still possible in the General Residential Zone, and should be reduced to 9m
- Inclusion of advertising for single dwellings in the General Residential Zone
- Protection of mature trees on private land

The draft plan failed to include any future planning for traffic and parking. We put in a separate submission and are dismayed at the continual waiver of parking for developments in Hitchcock Ave.

In August we presented to the Panel set up by the Minister for Planning. We strongly opposed the Amendment on the basis that it facilitates a level of change that is incommensurate with the strategic and policy context of this small coastal town, and will undermine valued aspects of local character. We argued that if the proposed Design and Development Overlays (DDO41 and DDO42) are intended to identify and preserve local identity they fall well short of the mark, as they seek generic built form outcomes that fail to establish a sense of place or preserve the special qualities of our coastal location.

We wait for the recommendations from the Panel and the CoGG reaction.

## 1 Flinders Pde

The Council failed to deal with the planning application for an apartment block on the most important site in our village. The developer took the application to VCAT and was successful in this application. Council decided out of time that it would have refused the application, but failed dismally to defend this decision at VCAT. A sole Council officer with no experts to support his argument was like a lamb to the slaughter against legal Senior Council, and four experts. We didn't have the resources required to put up a proper fight. A very disappointing process.

### **Developments in Hitchcock Ave**

We are witnessing proposals for significant developments in Hitchcock Ave. All require waiver of parking. We cannot understand why this is so easy, and wonder where people are meant to park. The area is currently very busy, and with the proposed developments will become saturated with out review of parking and traffic. Traffic reports accompanying 3

major development applications and accepted by Council all have the same statistics from a 2 days in winter, to justify the waiver of 36 car parking spaces

# Proposed childcare centre in Geelong Rd

This is a proposal by a private developer. Our main concerns have related to traffic and parking. This application has not been decided by Council.

### **Traffic & Pedestrian Safety**

The pedestrian crossings have made Barwon Heads safer for pedestrians, locals and visitors. It has slowed down traffic in the very busy pedestrian streets; but cannot be to blame for the traffic jams that have occurred in town over the past 5 years during the peak holiday seasons. Vic Roads shared some GPS data (tom-tom) with us, which was not very satisfactory. Council has little interest. We are currently involved in discussions about proposed improvements for the 2018/2019 Christmas/New Year periods. We continue to express our concern about the speed of motorists through Barwon Heads and in particular the size and number of large trucks that are now using Barwon Heads as the truck route.

### **The Barwon Heads Library**

Our Library continues to grow and is now a role model for other small community libraries. The Friends of the Barwon Heads Community Library was formed with the support and encouragement of the BHA. It has had numerous events this year with strong community and school support and are listened to by the Library Corporation. Thank you to Karen Firth and her committee for their time and energy. Thank you to BHPS Principal Daniel Vella for his interest and availability. Hopefully our library is now safe.

# Old Kindergarten in Clifford Pde

This remains unresolved. We have initiated a number of meetings with the Lions Club, Scouts, Seniors and the Arts Council. A large group met with Council officers. Our message is we want this retained for community use. We will protest very loudly if Council proposes to sell it. Council has advertised its social infrastructure plan – nothing in it for Barwon Heads (we are too small).

#### Safety & Security

This has continued to be a major focus during the year. There are a number of initiatives that we continue to participate in. Personal and community safety is a high priority for all. The BHA is a member of the Bellarine Community Safety Group, initiated and chaired by the Hon Lisa Neville. This participation has given us direct access to senior and local police. We now know our local police and share the discussion with other community representatives from Queenscliffe, Portarlington, Indented Heads, Ocean Grove, Drysdale and St Leonards. Judith Brooks and Geoffrey Waite regularly attend these meetings. We have remained involved with the Bellarine Police Community Support Register, a confidential register of personal information that is voluntarily provided by people living on the Bellarine Peninsula, in conjunction with Bellarine police. Jeremy Gaylard was our representative.

#### **ACKNOWLEDGEMENTS**

We continue to form close relationships with other community groups. In particular the Barwon Heads Arts Council; Save Barwon Heads Alliance; the Barwon Heads Senior Citizens (for friendship & the use of their facility) and the Ocean Grove Community

Association. We also have strong working relationships with Barwon Coast and the City of Greater Geelong.

I thank all of the Committee for their efforts this year:

- Jeremy Gaylard has been a very supportive Vice President; he retired earlier in the year and has relocated closer to Geelong;
